Notice of the 47th Annual General Meeting, Remote e-voting information and Book Closure

NOTICE is hereby given that the Forty Seventh Annual General Meeting ('AGM') of the members of Manugraph India Limited ('the Company') will be held on **Thursday, December 12, 2019** at 12.00 noon at M.C. Chia Hall, Bhogilal Hargovindas Building, 18/20, Kaikhushru Dubash Marg, Mumbai - 400 001, India, to transact the businesses as set forth in the Notice of the AGM dated November 8, 2019.

Electronic copies of the Notice of the AGM and the Annual Report for the financial year 2018-19 have been sent to all the members whose email IDs are registered with the Company / Depository Participant(s). These documents are also available on the website of the Company at www.manugraph.com. The Notice of the AGM and the Annual Report for the financial year 2018-19 have been sent to all other members at their registered address in the permitted mode. The dispatch of the notice of the AGM and Annual Report has been completed on November 17, 2019.

In compliance with Section 108 of the Companies Act, 2013, and Rule 20 of the Companies (Management and Administration) Rules, 2014, Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, the Company is pleased to provide electronic voting facility to all its members to exercise their vote by electronic means on all resolutions set forth in the Notice of the AGM through the platform provided by Link Intime India Pvt. Ltd. (<https://instavote.linkintime.co.in>).

The Company hereby informs to all its Members as under:

- i. The businesses as set forth in the Notice of the AGM may be transacted through voting by electronic means;
- ii. Remote E-voting period shall commence at 10.00 a.m. (IST) on Monday, December 9, 2019, and end at 5.00 p.m. (IST) on Wednesday, December 11, 2019. The e-voting module shall be disabled by Link Intime thereafter;
- iii. The Cut-off date for determining the eligibility to vote by electronic means or at the AGM is Thursday, December 5, 2019;
- iv. The Notice containing e-voting procedure is also available on Link Intime's website <https://instavote.linkintime.co.in> and on the Company's website www.manugraph.com;
- v. Any person who acquires shares after the dispatch of the Notice of the AGM and holds shares as of the cut-off date may obtain login id and password by sending a request at enotices@linkintime.co.in.
- vi. Members may note that: a) the remote e-voting module will be disabled by Link Intime beyond 5.00 p.m. IST on Wednesday, December 11, 2019 and once a vote on a resolution is cast by a member, he/she shall not be allowed to change it subsequently; b) The facility for voting through ballot paper will be made available at the AGM for members present at the meeting; c) The members who have cast their vote by e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again; and d) Only persons whose names are recorded in the register of members or in the register of beneficial owners maintained by the depositories / registrars as on the cut-off date shall be entitled to vote using the remote e-voting facility or at the AGM using ballot paper. If member casts votes by more than one mode, then voting done through remote e-voting shall prevail and polling paper shall be treated as invalid.
- vii. Persons entitled to attend and vote at the meeting, may vote in person or by proxy / through authorised representative, provided that all proxies in the prescribed form / authorization duly signed by the persons entitled to attend and vote at the meeting are deposited at the Registered Officer of the Company, not later than 48 hours before the meeting.
- viii. If the member is already registered with Link Intime for e-voting, he can use his existing user id and password for casting vote through remote e-voting.

The Board of Directors have appointed Mr. Aashish K. Bhatt & Associates, Company Secretaries as the scrutinizer's to scrutinize the voting process. The result of the voting will be declared and the same along with scrutineers report will be uploaded on the website of the Company www.manugraph.com, Link Intime's e-voting website <https://instavote.linkintime.co.in> and stock exchanges.

Pursuant to the provisions of Section 91 and all other applicable provisions of the Companies Act, 2013 and Regulation 42 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulation, 2015, notice is also hereby given that the Register of Members and Share Transfer Books of the Company will remain closed from Friday, December 6, 2019 to Thursday, December 12, 2019 (both days inclusive), inter-alia, for the purpose of payment of dividend and AGM of the Company.
